#### WHAT IS GROUND WATER?

Groundwater is the water that soaks into the soil from rain or other precipitation and moves downward to fill cracks and other openings in beds of rocks and sand. It is, therefore, a renewable resource, although renewal rates vary greatly according to environmental conditions.

It also is an abundant natural resource.

Of all the freshwater in the world (excluding polar ice caps), 95 percent is groundwater. Surface water (lakes and rivers) only make up three percent of our freshwater.

#### **GROUND WATER'S IMPORTANCE TO THE ENVIRONMENT**

Hydrologists estimate, according to the National Geographic Society, U.S. groundwater reserves to be at least 33,000 trillion gallons — equal to the amount discharged into the Gulf of Mexico by the Mississippi River in the past 200 years.

At any given moment, groundwater is 20 to 30 times greater than the amount in all the lakes, streams, and rivers of the United States.

About a quarter of all U.S. rainfall becomes groundwater. Groundwater provides much of the flow of many streams; many lakes and streams are "windows" to the water table. In large part, the flow in a stream represents water that has flowed from the ground into the stream channel. It's estimated by the USGS that about 30 percent of U.S. streamflow is from groundwater, although it is higher in some locations and less in others.

All the water of the Earth including the atmosphere, oceans, surface water, and groundwater participates in the natural system we call the hydrologic cycle. As water moves through all these elements repeatedly, the system is truly cyclical. *Information taken from the ngwa website*.



Groundwater Awareness Week: March 6-12, 2016

"Time to schedule your annual water well checkup!"

Just as you check your furnace or smoke detector batteries seasonally, spring is a good season to have an annual water well checkup before the peak water use season begins, according to the North Carolina Ground Water Association (NCGWA).

#### Why is it a good idea to have my water well checked annually?

An annual checkup by a qualified water well contractor is the best way to ensure problem-free service and quality water, says NCGWA member name of individual of company name.

Also, preventative maintenance usually is less costly than emergency maintenance, and good well maintenance — like good car maintenance — can prolong the life of your well and related equipment. NCGWA further recommends you test your water whenever there is a change in taste, odor, or appearance, or when the system is serviced.

#### Schedule your annual water well checkup

Wells can provide high-quality drinking water, and about half the U.S. population receives its drinking water from wells. But with well ownership comes the responsibility of keeping the water well in good working order. A check of your well by a qualified water well contractor may include:

- A flow test to determine system output, along with a check of the water level before and during pumping (if possible), pump motor performance (check amp load, grounding, and line voltage), pressure tank and pressure switch contact, and general water quality (odor, cloudiness, etc.).
- A well equipment inspection to assure it's sanitary and meets local code.
- A test of your water for coliform bacteria and nitrates, and anything else of local concern. Other typical additional tests are those for iron, manganese, water hardness, sulfides, and other water constituents that cause problems with plumbing, staining, water appearance, and odor.

Last name of member also recommends that well owners:

- Keep hazardous chemicals, such as paint, fertilizer, pesticides, and motor oil far away from your well, and maintain a "clean" zone of at least 50 feet between your well and any kennels and livestock operations.
- Maintain proper separation between your well and buildings, waste systems, and chemical storage areas.
- Periodically check the well cover or well cap on top of the casing (well) to ensure it is in good repair and securely attached. Its seal should keep out insects and rodents.
- Keep your well records in a safe place. These include the construction report, and annual water well system maintenance and water testing results.

NCGWA president Chauncey Leggett and I joined 50 other drillers, geologist and engineers from around the country representing 28 states for the NGWA fly in. This event took place Feb. 22-23 in Washington D.C.

Chauncey and I met with both our Senators and Congressmen's legislative aides on four specific topics prepared by NGWA. One of which was extending the federal geothermal tax credit which was overlooked during the passing of the Omnibus bill in late December. We also discussed federal assistance on individual and small water systems defined in the water savings act which is Senate Bill 1642 & House Bill 3533. Both bills have bipartisan support and could have positive effects for NC. All received support for extending the geothermal tax credit until 2021 putting the credit on a level playing field with solar and wind.

I highly recommend all drillers getting involved with legislative issues that affect our industry on both a state and federal level. We elect these people and they truly enjoy discussing topics that are important to the people living in their areas.
